The following shall be an agreement between AAA Budget Motorcycle And Car Rental (Hereinafter referred to as AAA Budget), owned and operated at Stall No. 30 Ultimate Make Over Raza Beauty Salon, Checkpoint Tent Balibago and at 18-H 3rd Street, Villasol Subd, Angeles City, Pampanga, Philippines, Telephone Nos. 0919-223-5672 / 0928-708-0315 / 0999-999-0658, by Ms. Julita F. Raza.

AND

The following person hereinafter is referred to as RENTER:

Whereas AAA Budget is a fully licensed Motorcycle and Car Rental Company and in consideration of AAA Budget agreeing to rent the RENTER a vehicle for agreed rental charge and subject to the RENTER agreeing to pay the fee specified herein and further agreeing to the terms and conditions specified hereunder the parties agree as follows:

1. The RENTER agrees with AAA Budget that the period of the contract is ____ day/week/month and there is no refund for early return under any circumstances. RENTER will supply original passport for sighting together with one photocopy of passport.

2. The RENTER must have a valid International or other lawful Driving License accepted in the Philippines.
3. The RENTER must comply with all Philippine road traffic laws including, but not limited to, wearing helmets and not driving whilst intoxicated.
4. Repairs damages. The RENTER is responsible to compensate AAA Budget for any damage to the vehicle at conclusion of rental whether damage is caused by RENTER or any other party.
5. The RENTER shall be liable to pay for extended rental as long as the vehicle is in the repair shop for any damage occurring during rental.
6. The RENTER will be liable to pay for replacement of vehicle in cases of theft occurring during rental.
7. The RENTER acknowledges that all vehicles have only third party liability insurance for third party damage limited to P50,000 and acknowledges that the RENTER is liable to pay for third party damage. Any additional insurance coverage is the responsibility of the RENTER.
8. The RENTER agrees to only use the vehicle for sightseeing purposes and on main roads.

9. If the vehicle breaks down or is damaged, the RENTER agrees to inform AAA Budget immediately and allow AAA Budget to make repairs.
10. If the vehicle breaks down within Angeles City, AAA Budget will be responsible to arrange, collect, and pay for it to be returned at AAA Budget's discretion. However, if it breaks down or is damaged outside Angeles City, the RENTER is responsible for costs of returning the vehicle to AAA Budget. In any event in the case of accident, the RENTER is responsible for the cost of returning the vehicle to AAA Budget.
11. During rental period, the RENTER must take good care of the vehicle, including checking oil and water in engine daily and maintaining tires. The RENTER must pay for any tires, repair punctures, etc.
12. Vehicles must be returned as is gas gauge level shows, otherwise the RENTER will pay cost of refueling fee.
13. The RENTER agrees to notify and pay further advance rental if RENTER wishes to extend rental contract subject to agreement of AAA Budget.
14. Late return penalty up to 1 hour no charge as grace period. 1-2 hours 1/3 daily Rental charge 2-3 hours late 2/3 daily rental charge over 3 hours late full day rental charge.
15. AAA Budget will supply free of charge 1 or 2 helmet(s). The RENTER shall be liable for loss or damage to helmet.
16. If vehicle breaks down not occasioned by negligence of RENTER, the RENTER will be entitled to a replacement unit or credit at direction of AAA Budget.
